Category B	Request for funding proposals from Primary cooperatives that are 100% owned by women	The organizations must be registered as a Primary Cooperative in terms of Cooperative Act [No 14 of 2005]
Category C	Request for Funding proposals from Primary Cooperatives owned by youth, women and people with disabilities that are involved in income generating production activities, excluding those within food production value chain activities	The organizations must be registered as a Primary Cooperative in terms of Cooperative Act [No 14 of 2005]
